Stefnir hf. (Stefnir Asset Management Company) is an independent financial company according to Act No. 161/2002 on Financial Undertakings. The company operates on the basis of an operating license from the Financial Supervisory Authority of the Central Bank of Iceland as a manager of UCITS pursuant to Act No. 116/2021 on Undertakings for Collective Investment in Transferable Securities (UCITS) and as an alternative investment fund manager pursuant to Act No. 45/2020 on Alternative Investment Fund Managers. The company's operating license also applies to asset management, investment advice, and the custody and management of unit shares or shares in funds for collective investment. Stefnir is a subsidiary of Arion Bank.

What is this product?

Type

The fund is an alternative investment fund marketed towards the public pursuant to the Alternative Investment fund Managers Act No. 45/2020. Alternative investment funds marketed towards the public have broader investment authorisations than UCITS. The fund's investment authorisations are specified in the section on investment strategy in its prospectus.

Objectives

Asset Allocation Fund C is a balanced fund. The fund's objective is to actively invest the financial resources of unit holders with a mixed portfolio of foreign and domestic bonds and equities. The fund invests in government bonds and government bond funds, bonds, bond funds, equities, and equity funds. The investment criteria for the fund are that 30% of its assets are in equities, either directly or through funds, and 70% of its assets are in bonds and bills, either directly or through funds.

The fund operates according to a predetermined investment strategy and will direct its investments towards opportunities that, in the opinion of the manager, are most likely to yield the best returns.

The fund is authorised to invest at its discretion in deposits of financial institutions (both domestic and foreign), bonds, bills, loan agreements, AIF and UCITS that invest in deposits, bonds, UCITS and AIF that invest primarily or exclusively in bonds, covered bonds, funds that invest in foreign or other types of bonds and bills, UCITS and AIF that invest in equities, along with listed and unlisted equities.

The fund's returns depend on the increase or decrease in the market value of the fund's assets during the investment period, i.e., the period during which you hold units in the fund. Investors should understand that the fund's value can decrease as well as increase, and they must be able to withstand price fluctuations, as short-term volatility can be significant. The fund is well-suited for those looking to invest for the long term, ideally three years or more.

Intended retail investor

The fund is marketed to clients of Arion Bank's Private Banking service. The fund is designed for both the general public and institutional investors, such as pension funds and companies, who wish to choose an investment option involving funds for collective investments operated and managed by professionals and in accordance with current legislation and supervision of such funds.

Term

The fund is an open-ended fund and has no maturity date. However, the manufacturer has the right to close the fund under certain circumstances, such as if the manufacturer deems it more favorable for the shareholders to close the fund or merge it with another fund. More information can be found in Article 8, Appendix I of the fund's prospectus. It is possible to purchase and redeem unit certificates in the fund on all regular business days under normal circumstances, with transactions prices based on the end of the business day. Orders received before the cut off time at 14:30 are settled after two business days. Orders received after the cut off time are settled after three business days. In exceptional cases, redemptions may be delayed.

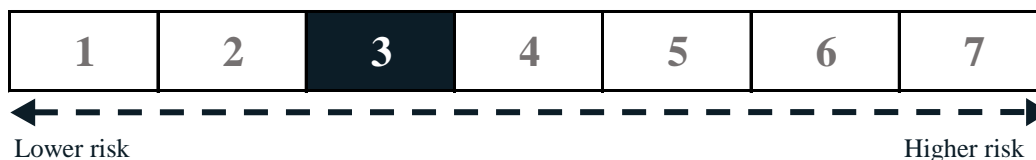
The fund was established on 22 June 2006.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

Risk factors affecting the product that are not covered by the risk indicator include counterparty risk, operational risk, and liquidity risk. Other risk factors may also be present. This product does not provide protection against future market performance, so you could lose your entire investment.

Counterparty risk: The risk of loss to the fund due to the counterparty failing to meet its obligations before the final settlement of the fund's transactions occurs.

Operational risk: The risk of loss to the fund due to inadequate internal processes and errors related to human resources and systems of the management company, or due to external events, including legal and political risks, and risks associated with trading, brokerage, settlement, and valuation procedures carried out on behalf of the fund.

Liquidity risk: The risk that it may not be possible to sell, redeem, or close a position in the fund's portfolio at limited cost and within an acceptable timeframe.

Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. Markets could develop very differently in the future.

What happens if Stefñir hf. is unable to pay out?

If Stefñir hf. becomes insolvent, there exists the possibility of incurring financial losses. The custodian of the fund (Arion Bank) keeps the assets of the fund separate from the assets of Stefñir hf. In the event of adverse outcome, there is a risk of losing the entire investment. What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

You should expect to hold your investment for 3 years or longer. Unit certificates can be redeemed at the owner's request at no cost, but the fund's distributor may charge a handling fee. Orders received before the cut off time at 14:30 are settled after two business days. Orders received after the cut off time are settled after three business days.
