Objectives and investment policy

Objectives

The sub-fund's objective is to seek long-term return by outperforming the MSCI WORLD net Total Return EUR Index.

Investment policy

The sub-fund mainly invests in:

- shares around the world,
- collective investment funds and/or investment funds traded on stock exchanges (maximum 10% of the net assets of the sub-fund),
- exchange traded commodities.

The investment manager integrates and promotes sustainability factors within his investment strategy by applying extra-financial data.

The portfolio is actively managed on a discretionary basis with reference to a benchmark. While the sub-fund compares its performance

against the benchmark, it does not try to replicate the benchmark and freely selects the securities that it invests in. The deviation with this benchmark can be significant.

The currency of the share class is expressed in EUR.

The investor has the right to redeem his shares on demand. The dealing in shares is carried out on each complete bank business day in Luxembourg. The attention of the investor is drawn to the fact that in exceptional circumstances, the possibility for the investor to request the redemption of his shares may be limited or suspended.

These shares are capitalisation shares. Income and capital gains are reinvested.

Recommendation

This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

What does this synthetic indicator mean?

- The shares of class A are classified in category 6 because the value of the share may be subject to high variations and consequently the risk of loss and the opportunity of gain may be high.

Which materially relevant risks are not adequately captured by the synthetic indicator?

- The investment in debt instruments bears a credit risk insofar as the issuer may refuse or be in a position where it is not able

to reimburse all or part of the interests or even of the principal due on the debt instruments. This may result in significant or even total losses of the value of the investments in these debt instruments.

- The market for securities issued by small- and mid-capitalisation companies is generally less liquid than the market for securities issued by large-capitalisation companies. This leads to a higher risk as certain subfund investments in the market for small- and mid-capitalisation companies may be temporarily unavailable for purchase or sale at fair value.
- The investment in underlying funds implies that the sub-fund is exposed to 1) the investment risks borne by the underlying funds, 2) the risk of increases in the level of charges borne by the underlying funds and 3) the risk that the underlying funds limit or suspend the right for their investors to redeem.

This share class may be converted into shares of another share class of the same sub-fund or of another sub-fund. A maximum conversion fee of 0.50% is charged for the conversion of shares.

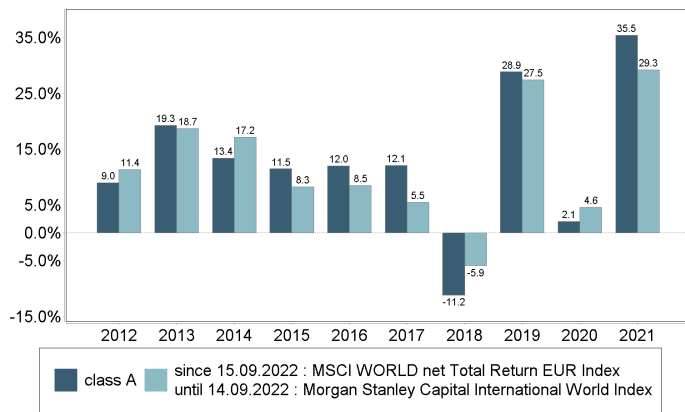
The ongoing charges relate to the annual charges; they were calculated on 31.12.2021. The ongoing charges may vary from year to year.
